Food Truck Instructions and FAQs

- Mannequin Night Event is held from 5:30-8:30PM
- Live Music will continue to play until 9:30PM
- Live Mannequins will pose from 6-8PM
- Food Truck spaces are limited.
- Spaces are 10 x 10 feet.
- Vendors may begin setting up at their assigned location beginning at **2:30 PM**.
- Vendors must be completely closed and ready to leave by **9 PM. No exceptions!**
- Vendors will be placed at the discretion of the event coordinators.
- Each vendor must be self contained according to the city of Paris. If electricity is needed please bring a generator.

Permits

All vendors must be registered with the City of Paris, and are responsible for obtaining the proper food and beverage licenses and complying with state and local health regulations. **Make certain that copies of permits/licenses required as part of your operation are attached** thereto, including, but not limited to health permits, electrical permits, business licenses, etc. A Health Permit will be required at each location. **You may not operate without a valid permit.**

Liability Insurance

Proof of liability insurance must be provided with this contract. All Food Vendors must provide insurance naming the City of Paris as additional insured on its policy. The policy will provide a minimum coverage of Five hundred thousand dollars (\$500,000.00) Combined Single Limits for Bodily Injury and Property Damage per occurrence and Five hundred thousand dollars (\$500,000.00) in the aggregate.

The following items must be submitted no later than **Monday, September 15th, 2025**. By submitting such form(s) and fee(s) later than the stated date above, you agree to pay an additional \$25 fee.

- ___ \$75 Fee (checks must have a Driver's License and be made out to Mannequin Night Inc.)
- ___ Notarized Hold Harmless State of Texas (can be notarized at your bank, the courthouse or Archer Construction)
- ___ Certificate of Liability Insurance
- ___ A Mobile Food Unit permit on file with the City of Paris
