ELECTRICAL: 110 and 220 outlets are available on a first come first serve basis. Generators will be allowed.

PLACEMENT: The Mobile Food Unit will be placed at the discretion of the event coordinator.

PERMITS/LICENSES: All vendors must be registered with the City of Paris, and are responsible for obtaining the proper food and beverage licenses and complying with state and local health regulations. Make certain that copies of permits/licenses required as part of your operation are attached thereto, including, but not limited to health permits, electrical permits, business licenses, etc. A Health Permit will be required at each location. **You may not operate without a valid permit.**

LIABILITY INSURANCE: Proof of liability insurance must be provided with this contract. All Food Vendors must provide insurance naming the City of Paris as additional insured on its policy. The policy will provide a minimum coverage of Five hundred thousand dollars (\$500,000.00) Combined Single Limits for Bodily Injury and Property Damage per occurrence and Five hundred thousand dollars (\$500,000.00) in the aggregate.

Please provide exact measurements of your concession stand/food truck including towing apparatus.
